# CLMV Regional Conference on Sustainable Development Goals (SDGs) Implementation

26-27 March 2018 | Bangkok, Thailand

## **CONCEPT NOTE**

#### ABSTRACT

The CLMV Regional Conference will highlight challenges and solutions facing the developing continental Southeast Asian states in their way towards implementing the 2030 Agenda domestically. The conference will have a special focus on unique approaches relevant to the context of the countries in question. This includes specific challenges to implementing and monitoring the SDGs and their progress, financing on the cusp of graduation from LDC-status as well as the involvement of various stakeholders in the SDG planning and implementation stages.

#### Objectives

- To exchange information about the implementation progress and main challenges facing the countries
- To get familiar with the existing guidelines for voluntary national reviews of the 2030 Agenda implementation
- To explore additional review mechanisms for SDGs with a spotlight on SDG12
- To get to know how to fund all the above in the context of LDC and LMIC-status

#### BACKGROUND

The adoption of the Sustainable Development Goals (SDGs) outlined in *"Transforming Our World: the 2030 Agenda for Sustainable Development"*<sup>1</sup> presents multiple challenges for countries to implement SDGs. Today, almost two years after the introduction of the SDGs, many stakeholders are ready to share their efforts to meet the 17 objectives and the challenges they have faced.

As a part of this process the group of CLMV countires has been engaged in the facilitated dialogue since 4 years that enables them an informal platform to exchange their experience and challenges related to the implementation of SDGs. The CLMV Regional Conference on Sustainable Development Goals (SDGs) Implementation is the forth regional event on the implementation of SDGs that have been jointly carried out by ASEF, HSF and the governments of CLMV countries since 2014, under the **Asia-Europe Environment Forum (ENVforum)**.

Established in 2003, the ENVforum is a partnership of the Asia-Europe Foundation (ASEF), Hanns Seidel Foundation (HSF), ASEM SMEs Eco-Innovation Center (ASEIC), and the Institute for Global Environmental Strategies (IGES). Since its inception 14 years ago, the ENVforum has organised over 50 high-level international meetings, roundtables, conferences and workshops, bringing together over 1,200 selected participants from governments, academia, international organisations, NGOs, civil society and the private sector. The ENVforum has produced a series of 9 prominent publications addressing essential issues related to sustainable development.

The conference is hosted by the Asian Institute of Technology (AIT) in cooperation with SDGs Transformation Lab. It will provide a forum for experts to exchange experiences on innovative financing for sustainable development, mobilising national resources and successful involvement of the private sector in the national planning process towards the 2030 Agenda. It is also designed to promote exchange between regional and international levels and highlight different approaches to Public-Private-Partnerships in Asia and Europe.
